

Terms and Conditions

Promoter

Promotion Period

The promotion commences 26 February 2021 00:01 (AEST) and closes on 15 April 2021 at 23:59pm (AEST) (“Promotion Period”). All entries must be submitted by 23.59pm (AEST) on 31 May 2021.

Conditions of entry
